**Treasurer's Report for December:** Receipts for the month of December totaled \$20,097.90, which amount is \$2,643.07 more than the amount budgeted for said month and Expenses for said month totaled \$20,742.80, which amount is \$3,287.97 more than the amount budgeted for said month. As of the end of December 2013 and the end of the

calendar year 2013, the Church has a surplus of \$16,433.55. Motion made to accept Treasurer's Report. **Motion passed.**
